THIS INDEMNITY AGREEMENT SHALL APPLY WHERE SUCH CLAIMS, INJURIES OR DAMAGES ARE OR WERE CAUSED BY LLUMC'S AND/OR WESLEY PREP'S SOLE NEGLIGENCE OR BREACH OF ANY DUTY OR THE JOINT NEGLIGENCE OR BREACH OF ANY DUTY BY LLUMC AND/OR WESLEY PREP, THEIR EMPLOYEES, AGENTS AND REPRESENTATIVES, AND/OR ANY OTHER PERSON OR ENTITY.
